Proforma relies on the customer's representation that they are authorized to utilize any copy or marks and Customer holds Proforma harmless and will indemnify Proforma for any and all claims resulting from printing, embroidery or other embellishments performed for customer by Proforma.

OVERRUN/UNDER RUN FOR PRINTED PRODUCTS Proforma makes every attempt to ship exact quantities. Due to our post-production quality control efforts and the high speed of the custom production process, there is a potential for up to a 10% over/under runs.

PRODUCTS & COLOURS Proforma Promotional Products Canada cannot guarantee exact shade, colour, size, texture, or construction of finished goods as they vary from lot to lot. Exact duplication of colours including PMS (pantone matching system) colors is not always possible, Proforma will match the colors as closely as possible.

CANCELLATIONS, CHANGES & RETURNS Accepted only with prior written approval from Proforma Promotional Products Canada. Any costs incurred by the Seller prior to acceptance of cancellation will be invoiced. No cancellations will be accepted if order is in production.

SHIPPING AND HANDLING CHARGES Prices listed do not include shipping and handling charges. All merchandise is shipped FOB origin - we repay shipping costs and add it to the invoice. Merchandise is shipped either via Fed Ex, UPS or truck depending on weight, date needed and delivery location. Proforma is not responsible for delays, lost goods or damages caused by the freight carrier but will assist in tracking shipments. Shipping dates are estimated and not guaranteed.
